
Objectives

PREVENTATION AGAINST RAGGING

Ragging is strictly prohibited by Law in and outside the college campus. UGC circular no. F 1-16/2007 (CCP II) dated 17 June 2009

College identifies following actions as Ragging

- 1) Any disorderly conduct, action or unlawful gathering.
- 2) Use of words spoken written causing violation of decency and morals.
- 3) Actions or words with the effect of teasing, treating or rude handling.
- 4) Use of words, or actions causing hardship, psychological harm or create fear in the freshers.
- 5) Rowdy or undisciplined activities causing annoyance.
- 6) Actions like assault, injury to body or any sexual offence.
- 7) Any compulsion to perform acts that generate sense of shame or embarrassment.
- 8) Wrongful restrain or confinement.
- 9) Use of criminal force or criminal trespass.
- 10) Offence against property.

Following actions can be taken as punishment for Ragging.

- 1) Cancellation of admission.
- 2) Suspension from attending classes.
- 3) Withholding / withdrawing scholarship or other benefits.
- 4) Debarring from examination.
- 5) Withholding results.
- 6) Expulsion from the institute.



The cell provides a mechanism for redressal of grievances of students and all other stakeholders. It ensures transparency in admission and prevents unfair means. The Grievance Redressal Cell of the college desires to promote and maintain a helpful, encouraging and unprejudiced educational environment. The Cell enables a stakeholder to express his/her feelings freely and frankly by initiating and pursuing the grievance procedure in accordance with the rules and regulations of the UGC.

Students are encouraged to submit their grievances on academic or non-academic matter through the grievance collection box.

The Grievances of stakeholders are enquired, analyzed and solved in a strictly confidential and fair manner. In order to maintain a harmonious educational environment in the college, the cell helps to develop a responsive and responsible attitude among the students and all stakeholders.

The Cell ensures effective solution to the grievances, using a fair approach. The Grievance and Redressal Cell enables the students to express their grievances by initiating and following the grievance procedure in accordance with the rules and regulations of the College. The cell meets periodically, examines the nature and pattern of the grievances and redresses it accordingly.

- 5. To define and develop S.O.P. for grievances.
- 6. To develop an organizational framework to resolve grievances of the students and other stakeholders.
- 7. To ensure effective solution to the stakeholders' grievances with an impartial and fair approach
- 8. To investigate the reason of dissatisfaction.
- 9. To enlighten the students on their duties and responsibilities.

Functions

- 1. The complaint box is checked per Saturday by committee members.
- 2. The cases are attended promptly on receipt of grievances from the students and all stakeholders
- 3. The cell formally reviews all cases and prepare statistical report about the number of cases received
- 4. The cell gives a report to the authority about the cases attended to and the number of pending cases,

if any, which require direction and guidance from the higher authorities.

- 5. The Grievance Redressal Cell acts upon those cases which have been forwarded along with the necessary documents.
- 6. The Grievance Redressal Cell assures that the grievance has been properly solved in a stipulated time limit provided by the committee
- 7. Action is taken at the earliest depending on the nature of complaint

UGC guidelines, norms and definitions:

- 1. Act means the University Grants Commission Act, 1956 (3 of 1956); Aggrieved student means a student who has any complaint in the matters concerned with the grievances defined under these regulations, and includes a person seeking admission to any institution of higher education;
- 2. College means institution, whether known as such or by any other name, which provides for a course of study for obtaining any qualification from a university and which, in accordance with the rules and regulations of such university, is recognized as competent to provide for such course of study and present students undergoing such course of study for the examination for the award of such qualification.
- 3. Commission means the University Grants Commission established under section 4 of the UGC Act, 1956.
- 4. Grievance Redressal Committee means a committee constituted under these regulations.
- Higher Educational Institution means a University within the meaning of clause (f) of Section 2, a college within the meaning of clause (b) of subsection (1) of Section 12A, and an institution deemed to be a University declared under Section 3, of the University Grants Commission Act, 1956.


Grievances Resolved Report Year: 2018-2019




